## PROCESSING INSTRUCTIONS

Before processing, the release agent should be brought to room temperature and shaken well.

The mould surfaces must be clean, dry and free of dust and grease.

Lacquer and sealant layers should be well dried or hardened.

Apply Release Agent QZ 5111 with a brush or cloth.

After application, the release agent must be flashed off for 10-15 minutes and then polished.

Repeated application is usually necessary, especially with open-pored surfaces (BM 5460/GP 620).

Possibly, work with wax release agent GP pasty (Art.-No. 8t100).
